## CONDITIONS FOR APPROVAL (P)

- There shall be a <u>separate Governing Council</u> for the Institution and it shall be constituted as per the guidelines prescribed by the ATCTE from time to time.
- 2. The infrastructural, instructional and other facilities including teaching staff, equipment etc. shall be provided as per AICTE norms prescribed from time to time.
- 3. A <u>building</u> with required space as per AICTE normal and it be provided <u>exclusively</u> for this programme.
- A <u>library</u> shall be established with adequate number of tibles, books, journals (both Indian & Foreign) etc.
- A computer Centre with adequate number of terminals.
  Printers etc. shall be established.
- name in intake of these courses without prior approal of the AIDTE.
- The teathing staff shall be in the pay-scales as ish the AICTE guidelines prescribed from time to time.
- i. The faculty shall be recruited as per norms, procedure qualifications etc. as prescribed by the AICTE from time to time and the selection committee for recruitment shall have the representation of the University and the AICTE also.
- 9. The admissions shall be made only after advocate infrastructure and all other facilities are provided as per norms and guidelines of the AICTE/Govt. of India/State Sovt. and that affiliation of the University has since been obtained.
- 10. The tuition and other fees shall be charged as prescribed by the competent Authority within the overall priterial prescribed by the AICTE from time to time.
- 11. The administrative, academic and financial records including accounts shall be maintained for this Programme. The accounts shall be audited annually by a Chartered Accountant and all the records and reports shall be open for inspection by the AICTE or anybody, authorised by it.
- 12. The curriculum of the course, the procedure for evaluation assessment of students shall be in accordance with the norms prescribed by the AICTE.

- 13. The Management shall follow all conditions as may be laid down by the AICTE from time to time and a registered legal undertaking to this effect shall be submitted to the AICTE by July 1995.
- 14. The endowment fund of Rs 10 lacs/- shall be treated explusively for the above programme and fixed decosite receipt shall be in the combined name of the Society and Nominee of the State Govt.
- is. The institute by wintue of the approval given by 40078 shall not automatically become dialment to any fivenciel grant or assistance from the Sentral or State Government.
- The information furnished in respect of the proposal small set factual and correct. In the event of any information found to be false, mislessing or suppressed the actrical accorded may be withdrawn by the AICTE.
- 17. The institution shall furnish requisite returns and legists as desired by AICTE in order to ensure proper maintenance of administrative and academic standards. The progress report on fulfillment of the above conditions as on 31st. December, and 31st. May of each year shall be submitted by the Institution to the AICTE during 1995-97.
- 13. This approval is further subject to full-compliance with the "SCHEME" as prescribed by the Supreme Court in its judgement dated 4.2.93 with regard to WP/c) No. 607 of 1992 in the case of UnniKrishnan and other etc. vs. State of Andria Pracesh and others etc. and the related guidelines and criteria as may be issued by the AICTE, USC or the Central Government from time to time.
- In the event of non-compliance by the Society with regard to guidelines. norms and conditions laid down by AICTE from time to time, the AICTE or a body or person authorised by it will be free to take measures for withdrawal of its approval without const. Intion of any related issues and that all liabilities arise but of such a withdrawal would solely be that of the conce. Society.
